## **Proposed Rules for New Members to Contest for Election to** The Central Managing Committee


#### The following changes are proposed.

#### <u>DIRECTOR'S ANNUAL REPORT FOR THE PERIOD</u> 01/04/2022 - 31/03/2023

Indian Personnel Export Promotion Council (IPEPCIL) was formed on 4<sup>th</sup> June 1979 and has completed 44 Glorious years. The Managing Committee of IPEPCIL takes pleasure in presenting the Annual Report on the activities carried out during the financial year 2022–2023.

The 43<sup>rd</sup>Annual General Body Meeting was held at YMCA INTERNATIONAL HOUSE, Agripada, YMCA Road, Mumbai Central, Mumbai-400 008 on SATURDAY 24<sup>TH</sup> SEPTEMBER 2022 at 6.30 PM. 63members attended the meeting.

#### The minutes of the meeting are as follows:

#### 1. REGISTRATION AND FELLOWSHIP:

The registration and fellowship for the meeting started at 6.30 p.m. along with Tea/Coffee. Since the quorum was not present, the meeting was adjourned till 7pm on the same day & same place.

#### 2. WELCOME SPEECH BY MR. FAHAD HAROON MEMON, GENERAL SECRETARY:

General Secretary Mr. Fahad Haroon Memon started his welcome speech by thanking all the members who attended the meeting. A brief introduction of the agenda points and the tasks at hand were mentioned.

#### 3. PRESIDENTIAL ADDRESS BY MR. V.S. ABDULKAREEM - PRESIDENT:

Council President MR. V.S. ABDULKAREEM addressed the members present at the 43<sup>rd</sup> Annual General Meeting and informed of his disappointment at the low turn-out of the members for the AGM.

At this significant occasion, The President briefed in detail about the necessity of reviving IPEPCIL Platform, so that to represent HRA fraternity & stake holders of the trade effectively work with the Government Departments, Regulatory Ministry, Diplomatic Missions, UN Bodies, Expatriate Medical, Insurance Companies, Chamber of commerce, stake holders etc.

In his Presidential address, he has updated the status of work done towards the simplification of Expatriate Pre Medical check-up, Roll back the Equal distribution system to make it open to the RA fraternity and Emigrants.

During the period, PCC compliance was implemented for Saudi visa process. IPEPCIL pursued the matter very constantly & effectively, so that the compliance was withdrawn by the Authorities. IPEPCIL Management Team has represented regularly with PGE and SECRETARY MEA, to resolve the PCC Issues. IPEPCIL MC was in regular touch with PGE/POE Offices to expedite smoothen the EC process and get it done quickly in all possible manner and also facilitated the RC related issues of the Member RAs to sort out the pending cases.

We have amended IPEPCIL Bye-laws for opening chapters wherever POE Offices are situated and also amended the Bye-laws for the young legal heirs to contest election for IPEPCIL Managing Committee.

The President emphasized for a National Level Unity among the Recruitment Agencies. To strengthen the platform of RA fraternity to achieve the Goals & objectives of our Trade Association.





#### 4) ANNUAL REPORT FOR THE FINANCIAL YEAR 2021-2022 (01.04.2021 to 31.03.2022)

General Secretary Mr. Fahad Haroon Memon informed the Members that copies of the Annual Report were circulated alongwith the notice to attend the AGM to all the members of Council.General Secretary Mr. Fahad Haroon Memon read out the entire report and Members were asked if they have any clarifications. As no member had any objection, the Annual Report for the year 2021-2022 (1st April 2021 to 31st March 2022) was accepted and passed.

# 5) <u>AUDITED ACCOUNTS & BALANCE SHEET FOR THE YEAR 2021--2022</u> (1st April 2021 TO 31ST MARCH 2022):

General Secretary Mr. Fahad Haroon Memon, informed the members that the Audited Accounts and Balance sheet have been circulated through Bulletin No.15 dated 2 September 2022 and requested if anyone needs clarification or has any objection.

As no Member sought any clarification, the Audited Accounts for the year 2021-2022 (1st April 2021TO 31ST MARCH 2022) were accepted and passed.

It was proposed by: Mr. Anis Bhai and seconded by Mr. Arif Gheewala

#### 6) APPOINTMENT OF AUDITORS:

General Secretary Mr. Fahad Haroon Memoninformed members that the services of our existing auditor Mr. Tanna were unsatisfactory and therefore a New Auditor MR. MOHD. SAFWAN LALPARIA OF M/S. MSL & CO. was proposed to be appointed as Council's auditor for the financial year 2022-2023 with a remuneration of Rs.10,000/- for their services. Since there was no objection from any member, the same has been passed.

RESOLVED THAT MR. MOHD. SAFWAN LALPARIA OF M/S. MSL & CO.be appointed as the Auditor for the Accounting year 2021-2022 with a remuneration of Rs.10,000/- (Rupees: Ten thousand only)."

It was proposed by: Mr. Ammaruddin Khan and seconded by Mr. Anis Bhai

#### 7) RE-APPOINTMENT OF COMPANY SECRETARY, MS. RITIKA AGRAWAL:

General Secretary Mr. Fahad Haroon Memon informed members that our existing Company Secretary, Mrs. RITIKAAGRAWAL of M/S. RITIKAAGRAWAL & ASSOCIATES to be re-appointed as our Council's Company Secretary for the ROC related matters and filing of annual return for the year 2022-2023, with a remuneration of Rs.12,500/- (Rupees: Twelve thousand five hundred only) for their services. Since there was no objection from any member, it has passed unanimously.

"RESOLVED THAT Mrs. Ritika Agrawal of M/s Ritika Agrawal & Associated should be appointed as the Company Secretary for the year 2021-2022 with a remuneration of Rs.12,500/- (Rupees: Twelve thousand five hundred only)"

It was proposed by: Mr. Arif Gheewala and seconded by Mr. Ayyaz Nasser.





#### 8. IPEPCIL CHAPTER:-

Council President MR. V.S. ABDULKAREEM addressed the members present and informed that IPEPCIL has amended its by-law and incorporated the norms of rules & regulations to have "Chapters" across The Indian region. It has become a necessity to convert IPEPCIL as an All-India Association with a wider perspective and to represent the RA fraternity of India in an effective manner.

If we continue to stay divided, we will not have strength & unity, and the policymakers regulating the sector will not hear our voice and will not take our representations seriously.

As per our verifications & survey, we find that none other than IPEPCIL has maintained the statutory compliances to stand as an association to represent the RA fraternity.

Other than statutory compliances maintained perfectly over a period of 4 decades, IPEPCIL has its own office premise & infrastructure facility to convert as a National Body. So, we invite your expressions of interest to join with IPEPCIL & to form the chapter in your respective region.

It was passed unanimously and all members approved of it.

#### 9) ELIGIBILITY TO CONTEST ELECTION:-

It was proposed to make the following ammendments in the Bye-laws with regards to eligibility of members to contest elections to the Central Managing Committee.

- 1. That Proprietor, All Partners and All Directors whose name appears in the MEA Registration Certificate OR their name does not appear in the RC but his name is mentioned in his application for issuing of the License and the Registering Authority has approved the same shall be entitled to be a Member and can contest the Election for the Managing Committee of IPEPCIL.
- 2. As the guidelines of Protector General of Emigrants, Registering Authority i.e. PGE, New Delhi has allowed legal heir for change of constitution, (i.e. Father, Mother, Brother, Sister, Husband, Wife, Son, and Daughter) therefore it was suggested that the IPEPCIL Members can nominate their legal heir to contest the Election of MC Members provided that the Member has registered their name as Legal heir, and informed to IPEPCIL in writing to Register the Legal heir's name.

It was passed unanimously and all members approved of it.

#### 10) IPEPCIL MEMBERSHIP CAMPAIGN AND SPECIAL DRIVE :-

Council President MR. V.S. ABDULKAREEM addressed the members present and stated that, a special membership drive has been approved by the Managing Committee for a period upto 31<sup>st</sup> March 2023 with a waiver of entrance fee of Rs.1000/-

IPEPCIL, Managing Committee has decided to strengthen its Membership base from all the regions of India, so as to make an effective Representation in National Level with the concerned Ministries, Embassies, Consulates, Expatriate Medical check, PGE/POE Offices, UN's extended arms of ILO & IOM, MEA appointed Forum of ICM & All stake holders related to the trade in National & International Level for its betterment, Legal & safe mobility of Emigrants population of India.





Following are the decision taken by the Managing Committee to increase the Membership from across India as special drive.

Waiver of Admission/ Entrance Fee of Rs. 1,000/- to admit New Membership in both the Categories(Active Member & Life Member) for a period up to 31.12.2022.

1. Current fee structure for the Active Membership: Entrance/Admission Fee : Rs. 1,000/-Active Annual Membership Fee : Rs. 3,000/-

2. For the Life Member. Entrance/ Admission Fee Rs: 1000/- & Life Membership Fee of Rs 30,000/- (Rs. Thirty thousand only).

So, the intended RAs WHO wish to become a Member of IPEPCIL, need to pay Rs. 3000/- (Rs. Three thousand only) OR Rs. 30,000/- (Rs. Thirty thousand only) respectively for the period up to 31.12.2022.

Our Council received good response and a substantial number of members from different regions of India enrolled and became active/life members of IPEPCIL.

IPEPCIL is the Apex & largest Trade Association representing the Govt. Approved RA fraternity who elevate all trade related issues to the Regulators, Embassies, Consulates and all other stake holders in the Overseas Recruitment verticals for the smooth functioning & systematic process of Recruitment & Mobilization of Emigrants proceeding to Employment abroad. So, we have to have adequate infrastructure, credibility & Membership strength from all India Regions, so that we are heard by the regulators with an acceptance to consider our Representations seriously. If we are scattered &divided region-wise, all regulators will observe our dis-unity, so the seriousness will diminish & the matter will lose its importance and have a negatively impact. IPEPCIL has beenformed in the year 1979 & since then has been very consistently representing The RA fraternity with the regulatory bodies. IPEPCILhas its own ownership Office at Central Mumbai. It Maintains the ROC registration & its compliance is well updated like filing of income tax, ROC returns regularly & all statutory compliances promptly.

IPEPCIL is an Active Member of FICCI& ASSOCHAM as well.

We have inducted MR. M.C. Luther, Ex. PGE Retired, as our Strategic Advisor & also we have our Legal Advisor Advocate Mr. S. Balakrishnan in our panel, so our long-term strategy planning is under process.

IPEPCIL has a Membership Committee to take care the membership drive. The details of the Committee are given below to contact & co-ordinate with The RAs.

AGM unanimously passed a Resolution to urge members to make Voluntary Contributions to strengthen the financial standing.

#### 13.OPEN FORUM:

Council President Mr. V.S. Abdulkareem and General Secretary Mr. Fahad Haroon Memon explained in detail to the Members on various positive developments undertaken by the Managing Committee.

Mr. V.S. Abdulkareem stated the importance of Revamping IPEPCIL to represent the fraternity to the Regulatory bodies & state holders. The Newly constituted Managing Committee of IPEPCIL accordingly initiated the process of its Revival, formulated the strategies and the plan of action to make IPEPCIL an Active & strong body and to emerge into a National Association to represent HRA fraternity.

Mr. Athar Salim Qureshi, the Working Secretary also highlighted the contributions of our Association and the fact that our Association now has a goodwill with Government officials in MEA and also the various diplomatic missions.

Queries/questions raised by Members were answered by the President, Working Secretary and General Secretary to the satisfaction of the Members who were advised to be brave and come forward to solve their issues

They informed the Members of council in detail regarding the development and positive steps taken by the Newly Elected Managing Committee of IPEPCIL for the betterment of the Trade and its Members.

One of the Stalwarts of our field Mr. E.R. Khan gave a motivational speech and appreciated the efforts of our Managing Committee on actions taken to improve the process of Expat Medical Check and also said that the proposal of new Chapter Formation was a wonderful idea.

Ex- Joint Secretary Dr. Mustufa Punjabi also appreciated the efforts of our Managing Committee and requested all members to fully support our Association and come forward with voluntary contributions and said that failure to support the Association would be unappreciation of such a powerful ad wonderful Association.

#### 01) MANAGING COMMITTEE MEETINGS:

During the year 8 meetings were held. (Attendance details on Annexure-I)

#### 02) <u>MEMBERSHIP DETAILS:</u>

During the period1<sup>st</sup>April 2022 to 31<sup>st</sup>March 2023, we have admitted **32 New** Recruiting Agencies to our Council.Of these, 13 were Life Members and 19 were Active Members. (**Details on Annexure-II**)

During the period1<sup>st</sup> April 2022 to 31<sup>st</sup> March 2023,**13** New Ras became Life Members and **4** Active Members converted their membership to life membership(**Details on Annexure-III**)

During the year (2022-2023) we had 60 Active Members. (Annexure-IV). Out of this, 22 members have not paid their annual membership fees.

We now have 370 Life Members. (Details on Annexure-V).

This is a clear indication of the faith, trust and confidence of our members towards the Council.

#### 03) ANNUAL SUBSCRIPTIONFEES COLLECTION:

We have been able to collect Annual contribution fee of **Rs.1,56,000=00** (Rs. One Lakh fifty six thousand only) and Membership entrance fee Rs. **11000=00** Rs. Eleven thousand only). **Total amount collected was Rs.1,67,000=00** Rs. One Lakh sixty Seven thousand only)

**LIFE MEMBERSHIP FEE COLLECTION:-**In addition to the above, we have collected **Rs.5,25,000=00** from **17**newMembers as life membership fees.

Thus, the total fee collected during the year 2022-2023 (1stApril 2022 to 31st March 2023)is Rs.6,92,000=00 Rs. Six lakhs Ninety Two thousand only.

# 12) <u>INTER - ACTIVE SESSION WITH MR. M.C. LUTHER, PGE, RETD. STRATEGIC ADVISOR</u> CONSULTANTS-IPEPCIL:

**IPEPCIL** had scheduled an interactive networking think tank session on 2<sup>nd</sup> June 2022 from 11 am to 2 pm at the Board Room of Islam Gymkhana, Marine Drive. Mr. M.C. Luther, PGE Retd & our Strategic Advisor, attended the meeting to interact with our few RAs regarding the policy matters, issues & concerns of our trade and make strategies for the away forward. Meeting was be followed by networking lunch.

#### 13) APPEAL FOR DONATIONS TOWARD RELIEF FOR TURKEY EARTHQUAKE:

As all should be aware of the devastating earthquakes struck the Turkey & Syria borders. The death toll was huge and the rescue operations were on the ground & support was flowing in from the whole world.

The Turkish Consulate at Mumbai requested us to support by providing some Military Tents & provided us with the supply details.

IPEPCIL extended some possible support to them.

We have been able to collect donation towards relief of Turkey Earthquake of **Total amount** Rs.1,58,100/-(Rs.one Lakh fifty eight thousand one hundred only) till 31/03/2023. A further sum of Rs. 55,000/- was received in April 2023, taking the total collection to Rs. 2,13,100/-





**14) SAUDICONSULATE/EMBASSY**: During the year, our Council has metthe Hon'ble Consular/Vice Consul General of Saudi Arabiaraised various issues related to Recruitment fraternity, which were amicably resolved with the Consulate. Members were informed through the Bulletin regarding the important matters and Notifications. The details are as follows:

#### For the following points, IPEPCIL sent a letter to Saudi Embassy/Saudi Consulate:

- 1. Request to rollback sanitization compliance.
- 2. RA's Entry card Validity.
- 3. Request to Re-instate the submission time.
- 4. Request to revoke the compliance of PCC.
- 5. Request to Renew Entry Card of HRA's till validity of RC
- 6. Request to resolve Visa profession mismatch, Documents required, Cancellation of Visas.
- 7. Request to advise VFS to accept the Tourist, Personal visit, Student & Re-entry VISAs from the Consulate Accredited Agents.

#### 15) BUSINESS VISAS ISSUED BY SAUDI CONSULATE, MUMBAI:

We are happy to state that Saudi Consulate in Mumbai/Embassy New Delhi continue to issue business visas to Owners/Directors of Recruiting Agents who are recommended by our Council.

This year we have issued 96 such letters to our members and they obtained visas. Details of visa recommendation letter fees received for the Year April 2022 to March 2023 is **Rs.48,000=00**.

#### 16) GAMCA/GHC:

Managing Committee, strongly protested against the implementation of the new Directives of GAMCA and expressed our protest to GHC/GAMCA HQ. Detailed letters were sent to GAMCA Head Quarters, requesting for relief.

#### Following points IPEPCIL sent a letter to Saudi Embassy/Saudi Consulate:

- 1. Request to review & rollback online GAMCA/GCC Pre-Emp Medical check equal distribution system & re-instate the system prevails prior to GAMCA formation.
- 2. Non availability of medical updation at GCC site.
- 3. Deficiency in Medical MOFA updation.

IPEPCIL, President MrV.S.Abdulkareem, & the Managing Committee Member Mr. Owais Umar Dalwai had a meeting with Mr. Maitham Mansoor Almohamed at the headquarters of Expatriate Health Check Centre in Riyadh on 28<sup>th</sup> FEBRUARY 2023.

As discussed, we anticipate the review of the requested method of system to felicitate the pre-medical check smoothly which will definitely smoothen the process & remove the hardships, difficulties & the atrocities faced by the emigrants to complete the process and more over the process will lead to improve the image of the emigrant's traffic. So as to encourage the safe & secured migration of our emigrants & more specifically, the compliances will be under the Legal Metrology norms & the Competition Commission norms. They requested to expediate the review process at earliest.





#### 17) KUWAIT CONSULATE/EMBASSY:

IPEPCIL held a meeting with Consul General in Mumbai and highlighted the Grievances of our Members.

- 1. Request for an extension of time limit for the validity period of PCC already issued.
- 2. Request to increase the number of passport submission.

#### 18) POE-MUMBAI, MEA:

During the year, our council had several meetings withMr. Barhat Rahul Manhardan (IPS), POE-Mumbai.He was always very cooperative and supportive to sort out our problems.

- 2. IPEPCIL, Committee Members also had a meeting with the POE and PGE Mr. Brahma Kumar on **2**<sup>ND</sup> **MARCH 2023 at Videsh Bhavan, BKC, Mumbai.**

#### Following were the main points for discussion.

- 1. Simplification in approval of Nurses' category.
- 2. Allow all Female workers except Housemaids to be recruited through Registered RAs.
- 3. Settlement of Complaints / Grievances made by emigrants.
